The league business meeting was held on Tuesday, August 20, 1968. Highlights of the meeting were:

1. Charles Bruning Co. was accepted into the league in the place of Stewart Warner.
2. Annual 30-30 tournament was postponed until fall of 1969.
3. It was decided not to allow any more combined companies in the league.
4. It was decided that any team which forfeits more than 15 games during the season will be put on one year <sup>e</sup> probation.
5. It was announced that dues for 1968-69 season are payable Sept. 1, 1968 and are due no later than Dec. 1, 1968. Amount due is \$22.00 per club with the exception of ANL (\$44.00) and WE (\$33.00).
6. The 1967-68 schedule was unanimously accepted for 1968-69 season with a small change. Home matches are switched with those played away from home.
7. Jim Warren agreed to supply us again with interesting chess problems.
8. It was agreed that Ill. Bell Tel. postpones some of its matches until the strike will be over.
9. Last, but not least, on agenda was league's bulletin. The chairman announced that during last summer he sent his older son to a typing class, bought him a typewriter, enlisted help from his wife and now is ready to produce bulletins. There is only one catch to it. Each club will receive only one copy. It will be the responsibility of each team captain to multiply and deliver the bulletin on time to each member of his team.
