**And drink?** Spring water, preferably right from the source...  
 Mountain Dew when I need a buzz

**Do you have a favorite painter or artist?** jazz saxophonist Stan Getz

**How long have you been playing in the CICL?** since the late 1980s

**What do you see as your best result ever (in or outside the CICL)?** In a tournament game I beat a guy well over 2300. He didn't seem to take me too seriously (I was rated just under 2000) and happened to play into a position I'd been studying with GM games. It was an amazing feeling to know something deeper than a guy like that and it made up for many months of study. Nowadays, I'd just shrug and think "it happens", but the memory still makes me smile....I was once "on the way" up...

**Who is your favorite chess player of all time?** Rob Morris of the Motorola Knights, but Garry Kasparov is pretty good, too.

**What are chess players particularly good at (other than chess)?** arguing trivialities late into the night, whatever the subject. For proof, go to a CICL Business Meeting.

**Is there another skill or game you'd like to learn?** playing acoustic guitar

**If you could choose a superpower, what would it be?** reading people's minds, but then I'd need superpower "thick skin"

**Would you use your superpower in your chess game?** Hmm, might make the game a bit boring...most of the fun is outthinking your opponent while not knowing what he/she is thinking.

**If you had to choose an animal to play on your CICL team, what animal would it be?** Cats, you just know they're making evil plans...right when you think everything is all warm and fuzzy, they attack!

**Is there a chess book that had a profound influence on you?** Only one?...impossible! Alekhine taught me to play simply, but directly.. and also the love of annotating. Kasparov's works are all pure genius. Dvoretsky's training series (1980s) raised my rating to its highest. Rubinstein proved to me that 1.d4 is the best way to start a game. And who doesn't want to play like and as long as Kortchnoi? For a "desert island" wish, I guess I'd hope for any Kasparov book.

**If you could rename your CICL team any name, what would it be?** I have renamed the Walgreen teams several times, so you can see how unoriginal I am. Right now, something like "The Invisible Slouches" would be appropriate.

**What music do you like to listen to?** jazz guitar & saxophone, 70's rock

**If you didn't annotate chess games, what kind of games would you annotate?** backgammon

If you wrote a chess book, what would the title be? Hmm, this I've often considered. "Complete Guide to Blunders" or "Shooting Myself", or something like that. It would be full of my losses from winning positions....and there's enough for several volumes, many having nothing to do with chess (Like the time I was so deep in concentration, I hazily picked up the wrong piece, almost releasing it to an illegal square, only to finally focus on what was actually in my hand. The piece I'd decided upon was a couple squares away; I have no idea why my hand did what it did. But then my opponent did almost die... from laughing...).

**Would you prefer to be a webmaster or national master?** An interesting pairing-- both are time consuming, thankless, fairly solitary, not personally profitable and cover a wide knowledge. But the NM title would be infinitely more rewarding (for me, at least!).

### MINUTES

President Irwin Gaines called the meeting to order at 7:08 P.M. and welcomed the attendees.

#### **1. OFFICERS REPORTS:**

##### **A. President – Irwin Gaines**

Irwin said things went very well because all the chairmen and officers did their jobs well. He thanks them for their excellent work.

##### **B. Secretary – Jerry Thomas**

Jerry said there were no changes to the fall business meeting minutes published in the September bulletin. The minutes were unanimously accepted.

##### **C. Treasurer – Paul Freidel (via email)**

Please see the CICL web site for a summary of our 2011-12 budget, and the 2011-12 projected actual results based on the year so far. Due to an unexpected \$200 donation, we are track to finish the year with a \$228 surplus, compared with a projected \$25 deficit that was budgeted. The league is expected to finish the year with \$2,000 of net assets after paying all expenses, so we continue to be in a strong financial position.

I will be unable to attend the spring business meeting, so this report will have be in absentee. Please let me know of any questions, concerns or comments.

Additionally, please consider who might replace me as treasurer in future years. I've been very happy to serve for the number of years I've been treasurer, but a change in my personal life (foster parenting, and having 4 young children at home), is making it difficult to engage in the chess world for the time being.

At the meeting, Irwin explained that '\*' items have not been spent yet. He mentioned that although several teams of CICL players formed USAT teams, none of them publicized their membership in the CICL during the tournament nor requested their entry fee from the league. Attendees asked "what should be procedure to put together the CICL represented team." How to do this will be discussed at the Spring meeting.

Irwin agreed to follow up with Paul about the "To Be Received" entry under Assets. Attendees wanted to know if it means that these 3 teams still owe dues.

Irwin said since Paul can't continue for very long as Treasurer, we need to establish a search committee for a new treasurer. The Treasurer does not have to be a CPA.

**D. Division Chairmen:****West-Jeff Wiewel, Chairman(report via email)**

With ten teams we went with a nine-round round robin. All matches were completed and reported before the end of the season. Even forfeited individual boards were rare. The mild winter helped ensure that no matches were cancelled due to weather. During the season most matches were on time. One captain had to have his e-mail address corrected during the season.

The West MVP is Tenzing Shaw (Saint Charles) who went 8.5-0.5 during the season (Scott Allsbrook of the Tyros nicked him for a draw).

For the play-offs, the West's top three teams with guaranteed slots are:

1st) Downers Grove (8.5-0.5) (agreed to play in the play-offs, second seed, hosts Motorola Kings in the first round)

2nd) Saint Charles (7-2) (agreed to play in the play-offs, fifth seed, hosts DRW in the first round on 5/3 after swapping places with Citadel/UofC)

3rd) Wombats (6.5-2.5) (agreed to play in the play-offs, sixth seed, travels to Citadel/UofC in the first round after swapping places with Motorola Kings)

Fermilab (6-3) is the west's candidate for the wild card spot, but that play-off slot went to the North's second place team - Motorola Kings.

**North-Jim Thomson, Chairman (report via email)**

Congratulations to Jeff Balicki for being this year's North Division MVP winner! Jeff went 8-0 during the regular season this year with 69 points of rating improvement. This followed a perfect playoffs (3-0) last season as well. Jeff would tell you it's all random, but this is quickly pushing the bounds of what simple luck can do.

At the meeting, Jim said the North started with 6 teams and lost 1 (Walgreens) during the season. The Motorola Solutions Knights and Kings finished in 1<sup>st</sup> and 2<sup>nd</sup> place respectively. Jim said we need rules on how to handle team results (played and remaining) when a team drops out in the middle of the season. Also, for playoff determinations should the number of teams in the division include the dropped out team? Jim said that he kept the dropped team's results and forfeited their 1 remaining match in that round since they dropped out in December.

**East-Tony Jasaitis, Chairman (report via email)**

It was an exciting finish, with the top 3 teams, all already qualified for the playoffs, all tied for first place going into the final round.

The final order of the East Division Playoff Qualifiers is:

1. CITUC 8-1-1 on head-to-head-tiebreak over...
2. ROGUE 8-1-1
3. DRW 7-2-1

Now that the East Division schedule has been tuned to fit fairly well with the break/exam/other bad times of the universities, teams were able to stay rather closely to the schedule, rarely falling more than a week behind, and without

the side-effect logjams of other years. Perhaps frequent status checks by the Division Chair also helped.

For most of the season, three teams did not have home sites (BCBS, CHPTT, ROGUE), but we got by when those team were paired thanks other teams offering use of their home site. It also helped that BCBS finally got permission to use its home grounds near the end of the season.

The new teams CITUC, CHPTT (combined teams) and TLZOO (company team) worked out well, although TLZOO became marginal near the end of the season due to attrition.

## 2. OTHER REPORTS:

### A. Bulletin Editor –Patrice Connelly (via email)

Patrice said she was happy with the submissions and she will continue.

Attendees commented that she has done an excellent job and the bulletins are great.

### B. Webmaster –Tom Friske

No report. Irwin said Tom resigned as Webmaster and Games Editor and sent him the Web password. Irwin said he could continue to update the CICL web site with current news. The Web should be updated by each function, for example, rating chair for ratings, etc.

### C. Games Editor -Tom Friske

No report. Irwin said we need to divide out the entry of games as it is too much for 1 person. Free Web chess engines (chessdb is available at <http://chessdb.sourceforge.net/downloads/>) allow games to be saved as in PGN format after playing over them. Attendees agreed it would be nice if teams could enter via a link on the CICL Web page. For next season, a free tool might be developed for this and to email the PGN file to the games editor and opposing captain.

**The attendees agreed that each home team would be responsible for entering the games and emailing the PGN file to the games editor and opposing captain.**

We need someone to enter the playoff and individual tournament games. Jim Thompson and Irwin Gaines offered to help enter the games.

**For annotations, attendees agreed that every team would be required to annotate at least 1 game per season. Attendees thought some general comments and the match situation would increase interest. All felt these annotations did not have to be just from high level players.**

### D. Rating Chairman-Jeff Balicki(via email)

#### 1. 2011-2012 Season Rating Reports

a. Most Captains posted timely match submissions, often within 24 hours, via the online match entry tool. Similarly, a small handful of Captains posted scheduled match dates using the tool to communicate when an overdue match would be played; very helpful. The results from the tool automatically update the Division web page and serve as input to the CICL rating reports which are published on the CICL website. ALL of the division pages were kept up-to-date throughout the season this year. Thanks to all for your efforts in helping me to publish prompt, accurate, and frequent rating updates.

b. Last year's rating of Summer Tournament games delayed early season rating reports because game results were not provided on time.

#### 2. Rosters, NEW Player Information and Initial Ratings

The roster process put in place this year has made entering ratings much easier for the Captains and the ratings chairman. The combined roster and rating list was well received by the league as well. Captains and Division chairmen have done well to provide needed player rating information in a timely manner to support the process.

At the meeting, Jeff said no requests have been made for a Summer tournament. Rosters at the beginning of the season were well received and Division Chairs did a fine job enforcing roster submission. Jeff would prefer rosters be submitted early, like within days of the Fall meeting. Several teams said they didn't have rosters available that early.

**E. Publicity Chairman-Matt Vail (not present)**

No report.

**F. Banquet Chairman-Katherine Zack**

***Date: Friday June 1 with dinner at 6:45 P.M.***

All set with Alpine for June 1 and deposit given. Katherine will continue.

**G. Trophy Chairman-Chuck Dobrovolsky(via email)**

- It is still my desire to step down as trophy chair.
- I am updating a file that I keep for trophy/awards for this year.
- Thanks to Jeff Balicki's most recent ratings report, I have noted the cCenturion awards.
- I have also noted the need for a back-dated award for Caleb Romanowitz for MIP for the 2010/2011 season.
- I have noted the MVP for the West Division for this year (Tenzing Shaw).
- Prior to playoff Saturday, I need to hear from division winners and runners up as to their choice of Trophy/trophies/gift certificate/dues credit. The captain of teams eligible for awards should reach out to me to get the ball rolling.
- If I do not hear from the captain of a team that is eligible for trophy(ies)/awards for this year, I will assume the same award choice and plaque/name/plate wording as last year. Please bear in mind that the period of time between playoff Saturday and the banquet may not be sufficient for RTM to fill our order.

Chuck wants some help and to have that person take over the trophy chairman. RTM, the trophy vendor, is in Oak Lawn and someone in that area would be preferable.

**3. ELECTIONS and APPOINTMENTS****A. President**

Irwin Gaines agreed to serve. There were no other nominees. Irwin was unanimously elected.

**B. Secretary**

Jerry Thomas agreed to continue. There were no other nominees. Jerry was unanimously elected.

**C. Treasurer**

Paul Freidel is not continuing. There were no nominees..

**D. Publicity Chair (Appointed)**

Matt Vail agreed to continue.

**E. Division Chairmen (Elected by division captains)**

Division chairmen will be elected by their division's captains.

**C. TD(s) (NEED VOLUNTEERS)**

Art Olsen agreed to be tournament director and asked for another. Irwin said he would do assist, but was unsure if he would be available as he was flying back from Europe on Friday night.

**D. 2<sup>nd</sup> Tier Event(individual tournament)**

Irwin said there was no time to try to check about having a team event and so it will be an individual tournament. Time control will be Game/60 with a 5 second time delay if time clocks permit..

**5. BANQUET**

After discussion, attendees agreed to keep the banquet prices as per Katherine's email since payments have already been sent. We need to start pushing the banquet. Art asked if we could start the meal earlier so speed chess can begin earlier. Attendees agreed to have the meal served at 6:45 P.M. instead of 7 P.M.

Banquet speaker: After some discussion on what worked best, the following attendees agreed to contact chess players about presenting at the banquet:

Jeff Wiewel – contact some IM's he knows and Tenzing Shaw.

Jim Thompson – contact some of Motorola Solution's top boards

Irwin Gaines – check with Tony Jasaitis to see if he has any candidates from the East Division.

There was an open question about how much to pay the speaker, Irwin will check on what we paid prior speakers.

## 6. NEW BUSINESS

### A. Who should be included in division top 10 lists

From Jeff's ratings email report

A question was raised as to the criteria for Division Top 10 report. Currently the top ten report includes all players on a current team roster who have been credited with at least 9 rated games. Players on a roster who have not played a game in the current season are removed from the roster, and also this and all other reports, once all Divisions have reported all of their regular season match results. As a side note, there is a CICL extract available that may be used for individual reporting purposes as anyone sees fit.

At the meeting, attendees stated a preference overall for the report to include only playoff eligible players, especially later in the season. Rating report changes, including this one, are all at the discretion of the ratings chairman. Jeff plans to address the expressed overall preferences while maintaining some flexibility on the design and implementation of the change(s) to the report.

### B. Playoff pairing rules revisions

Jim Thompson agreed to write up a CICL Constitution update to explain how to handle pairing changes to match the USCF "use look ahead " rules. The USCF rules say to try to resolve all conflicts at once rather than top down one at a time (our current CICL rule). This item will be put on the Fall meeting agenda.

### C. How to Handle Team Dropping out before End of Season

Issues involve the number of teams to use in determining the Division playoff entries and which played results to use from the dropping team. This item will be put on the Fall meeting agenda.
